**ENTRY FEES:**

**Fees are listed in Canadian funds, and a federal GST tax of 5% must be added. For 2018 USA currency will be accepted at \$1.25 CDN for registration fees paid by cash or personal cheque (credit card payments will be automatically adjusted for currency exchange). Please submit payment in accordance with item A or B or with C or D, as applicable.**

**If received on or before midnight April 27:**

**A.** the entry fee for boats with an overall length of 21 feet or less is **\$55.13 CAD** (\$52.50 + \$2.63 GST)

**B.** for boats over 21 feet, the fee is **\$2.50 CAD** per foot of length overall

**If received on April 28, or later:**

**C.** the entry fee for boats with an overall length of 21 feet or less is **\$80.48 CAD** (\$76.65 + \$3.83 GST)

**D.** for boats over 21 feet, the fee is **\$3.65 CAD** per foot of length overall

**WAIVER AND RELEASE:**

I have read the Notice of Race for The Swiftsure Inshore Classic course for the 2018 Swiftsure International Yacht Race, and agree to be bound by the Rules therein and the Sailing Instructions or any Addenda to either document. I recognize the inherent and other risks in yacht racing activities and freely accept these risks. I have read and intend to comply with the Safety Equipment Requirements for the 2018 Swiftsure International Yacht Race as spelled out in the Notice of Race For The Swiftsure Inshore Classic. In consideration for participating in this event, I represent to the Royal Victoria Yacht Club that my vessel currently has, and will continue to have during the Swiftsure International Yacht Race, third-party liability insurance covering property damage, personal injury, and death in an amount not less than \$500,000 (Canadian or U.S.) per occurrence, and that the policy covers yacht racing activities. I agree to waive my rights to take legal action against and release and forever discharge the Royal Victoria Yacht Club, the Organizing Authority, the Swiftsure Race Committee, and their respective organizers, agents, officials, servants, representatives, and volunteers (collectively the “Organizers”) from and against any and all claims, actions, costs or expenses, and demands in respect to death, injury, loss, or damage to my person or property howsoever caused, arising out of, or connected with my participation in the Swiftsure International Yacht Race notwithstanding that the same may have been contributed to, caused, or occasioned by the negligence of the Organizers or any of them. I understand that this waiver and release is binding upon myself, my heirs, executors and assigns.
