2024 Swiftsure Organizing Authority Amendments to World Sailing Category 3 Monohull Offshore Special Regulations w/Canadian Prescriptions 2022-2023:

Interpretation of this important safety document.

- 1. This document contains amendments made by the Swiftsure Organizing Authority in conjunction with BC Sailing. They apply to all registrants in the Three Swiftsure Long Courses, except the Juan de Fuca Race for Multihulls.
- 2. These amendments apply to the World Sailing Offshore Special Regulations (OSRs) Extract for Category 3 Monohulls with Sail Canada Prescriptions.
- 3. There are separate World Sailing OSR and amendment documents for multihulls on the Swiftsure Official Notice Board.
- 4. Review this document in conjunction with the World Sailing Category 3 OSRs for monohulls on the Swiftsure Official Notice Board.
